- Support the maintenance of data quality through regular checks and audits.
- Manage large-scale data received from hospitals and assist in analyzing data to track program performance and outcomes.
- Conduct data extraction, analysis, and reporting using visualization and reporting tools to define and develop a data dashboard
- Work with multiple data streams present in the organization for reporting purposes.
- Travel to all districts and sub-district hospitals of the state to support data collection and verification processes.
- Contribute to the preparation of monitoring reports and presentations.
- Support the communication of monitoring findings to internal and external stakeholders.
- Establish a mechanism and periodically share generated data with the monitoring and program delivery team.
- Responsible for reporting according to the developed monitoring system with monthly, quarterly, and annual reports
  covering key CCP yearly targets.
